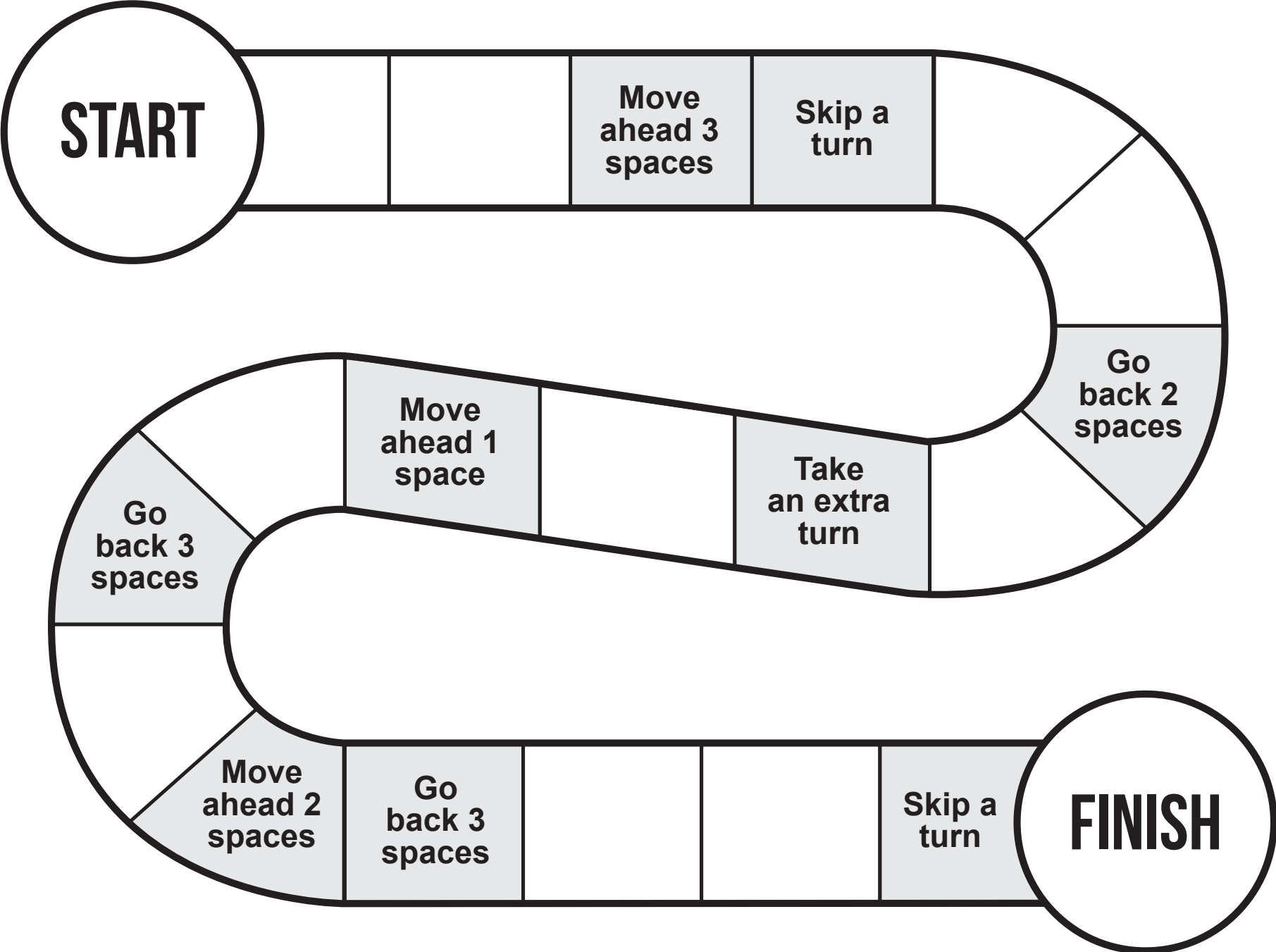

Motor Carriers

Is this a true statement?

Before hiring a driver, carriers will need to conduct a “full query” to request a driver’s record from the Clearinghouse.

Correct Answer: Yes, this is true.

Got it correct? Move ahead 3 spaces.

Got it wrong? Go back to start.



Motor Carriers

Fill in the blank.

Motor carriers will also be required to conduct a “limited query,” which simply asks the Clearinghouse if any violations exist, on each of its drivers at least _____ times per year.

Correct Answer: 1

Got it correct? Move ahead 5 spaces.

Got it wrong? Go back 2.



Motor Carriers

Is this a true statement?

If a violation does exist, the carrier must then request the full driver record using the “full query.”

Correct Answer: Yes, this is true.

Got it correct? Move ahead 3 spaces.

Got it wrong? Go back 1.



Motor Carriers

What are two examples of information that motor carriers need to upload about drivers?

Correct Answer: includes refusals to test, positive alcohol confirmation tests, and any actual knowledge that a violation occurred.

Is this a true statement?

Not all drivers need to register in the Clearinghouse.

Correct Answer: No, this is not true.

Got it correct? Move ahead 5 spaces.

Didn't get it correct? Move back 2 spaces.



Driver

Is this a true statement?

If a driver is applying for a new CDL driving job, he or she will need to log on to the Clearinghouse and grant consent for the hiring carrier to access their Clearinghouse record.

Correct Answer: Yes, this is true.

Got it correct? Move ahead 2 spaces.

Didn't get it correct? Move back 2 spaces.

Is this a true statement?

Drivers do not need to consent to a “limited query”.

Correct Answer: No, this is not true.

Got it correct? Move ahead 5 spaces.

Didn't get it correct? Move back 1 space.



Driver

Is this a true statement?

When drivers consent to do a limited query, they can do so outside of the Clearinghouse by signing a consent form provided by the motor carrier.

Correct Answer: Yes, this is true.

Got it correct? Move ahead 2 spaces.

Didn't get it correct? Move back 2 spaces.

Correct Answer: Clearinghouse
